



**REGULATORY DISCLOSURE
LIQUIDITY CONTRACT OPERATIONS**

Madrid, 30th April, 2015. In compliance with the current legislation, Fomento de Construcciones y Contratas, S.A. hereby issues the following regulatory disclosure in connection with its Liquidity Contract.

In connection with our Regulatory Disclosure dated July 26th, 2013, with registration no. 191238, regarding Liquidity Contracts, we hereafter detail the corresponding operations registered within the seventh quarter (as from 30th January, 2015 up to 29th April, 2015 inclusive) in accordance with Rule four, paragraph 2, letter b) of the National Securities Market Commission (CNMV) Circular 3/2007, of 19 December.

Due to the capital increase operation, registered on December 19th, 2014, this liquidity contract was temporarily suspended on November 18th (Regulatory Disclosure 214288) and reinstated on January 22nd (RD January 21st, 217446).
