

OTHER RELEVANT INFORMATION

Madrid, November 7, 2024. Pursuant to Article 227 of the Law 6/2023, of 17 March, of the Securities Markets and Investment Services (Ley de los Mercados de Valores y de los Servicios de Inversión) and related provisions, Fomento de Construcciones y Contratas, S.A. ("FCC" or the "Company") hereby discloses the following relevant information:

Following the announcement of "other relevant information" (*otra información relevante*) (OIR) published by FCC on October 30, 2024 (official registry no. 31127), FCC announces that, today, the public deed (*escritura pública*) relating to the financial partial spin-off has been registered in the Spanish Commercial Registry (*Registro Mercantil*) by virtue of which FCC has transferred en bloc (*en bloque*), without being extinguished, to Inmocemento, S.A. ("**Inmocemento**"), as beneficiary company, two economic units (*unidades económicas*) consisting the first one of them of 52,965,064 shares of FCYC, S.A. owned by FCC, which represent the 80.03% of its share capital, and consisting the second one of them of 154,453,657 shares of Cementos Portland Valderrivas, S.A. owned by FCC, which represent the 99.028% of its share capital, economic units that Inmocemento has acquired by universal corporate succession (*sucesión universal*), with all the assets, liabilities, rights, obligations and other elements inherent to the spun-off assets and liabilities (the "**Partial Spin-Off**").

Pursuant to the terms of the allocation announcement published by FCC on October 30, 2024, FCC shareholders who acquire their shares up to today, November 7, 2024, and who appear as such in the accounting records of the Sociedad de Gestión de los Sistemas de Registro, Compensación y Liquidación de Valores, S.A.U. (Iberclear) on November 11, 2024 (record date) will be entitled to the attribution of the shares of Inmocemento issued in the framework of the Partial Spin-Off.

In this regard, today, November 7, 2024, is the last trading date for the FCC shares with the right to participate in the Partial Spin-Off (last trading date) and tomorrow, November 8, 2024, will be the first trading date for the FCC shares without the right to participate in the Partial Spin-Off (ex date).

It is foreseen that a meeting of the Board of Directors will be held today, November 7, 2024, at which, among other issues, the initial reference price for the shares of Inmocemento will be set, which will be announced to the market by Inmocemento through the publication of the corresponding communication of "inside information" (*información privilegiada*) (IP) on the website of the Spanish Securities and Exchange Commission (*Comisión Nacional del Mercado de Valores*) and on its corporate website (<u>www.inmocemento.es</u>), along with the dates foreseen for the admission to trading of the shares of Inmocemento in the Barcelona, Bilbao, Madrid and Valencia Stock Exchanges through the Stock Exchange Interconnection System (*Sistema de Interconexión Bursátil*).
